### Vision

MCPS is committed to “promoting rigorous performance standards and providing instructional programs that encourage all students to achieve at their highest level.” We support and advocate on behalf of children who require accelerated and enriched instruction within MCPS in order to achieve their full potential. We seek to increase public awareness of the special needs of all highly able learners and to assist their parents in guiding the education of these children, in order to ensure that they are adequately identified and educated. We work to ensure that MCPS systematically provides appropriate programming to meet equitably each child’s unique gifts and talents in compliance with Policy IOA.

### Goals

1. Provide resources for parents in Montgomery County and support them in advocating for appropriate accelerated and enriched instruction for highly able students.
2. Identify effective acceleration/enrichment practices within MCPS, including practices developed for magnet programs, and promote their effective implementation in all local schools across the County.
3. Identify best practices from outside MCPS for education of highly able learners, including classroom and cluster grouping practices supported by research, and advocate for their implementation in all local schools across the County.
3. Represent MCCPTA on the Accelerated and Enriched Instruction Feedback Committee.
4. Advocate in support of the MCCPTA Resolution: Gifted and Talented Curriculum in Middle Schools, which was approved on April 25, 2006, including the promotion of “sequenced and systematic higher level gifted and talented curricula” in all grades and subject areas.
5. Advocate in support of the MCCPTA Resolution: Resolution on Accelerated and Enriched Instruction, which was approved on March 24, 2009.
6. Advocate in support of the MCCPTA Resolution: MCCPTA Resolution on Middle School Advanced Courses, which was approved on April 27, 2010.

### Action Steps

1. Advocate for appropriate GT education opportunities in all MCPS schools before the new Superintendent and his staff.
2. Continue to revitalize the Gifted Child Committee by recruiting local PTA GT Liaisons from every school in the County.
3. Continue the MCCPTA E-list for use by GT Liaisons to inform them of upcoming events or meetings, resources available and other items of interest.

4. Provide at least two informational/training meetings for GT Liaisons and other interested parents and members of the community. The meetings will include a fall Training Session for GT Liaisons, at which we will:
  - Disseminate general GT information regarding global screening, acceleration opportunities in reading and mathematics, and accelerated/center/magnet programs available to individual students and the mechanics and deadlines of applying to those programs.
  - Discuss any changes in programs, staffing, and transportation due to ongoing budget concerns and curriculum changes, and how schools can advocate for preservation of necessary programs
  - Alert liaisons to programs that exist in some MCPS schools and how they can advocate for expansion of such programs to their own schools.

We will solicit ideas for additional meetings from committee members.

5. Continue to monitor the curriculum changes involved with the roll out of the Common Core Standards and ensure that GT needs are being met.
6. Work with MCCPTA Website Chair to update the GCC web page as needed.

### **Expenses**

We estimate that our expenses will not exceed \$150 for refreshments/ snacks for our meetings. We found last year that it was quite a struggle to obtain ICB-fee free space for meetings and were only able to hold one such meeting, but we will strive to do so more successfully this year.
